

# St. John's Day School 2023 - 24

## EXTENDED SESSION / AFTERCARE

For and in consideration of St. John's Day School reserving a place in the school for the above-named student for the school year 2023 – 24 (hereinafter "School Year"), the undersigned agrees to pay the required annual aftercare fees. Fees will be retained by the school and are neither deductible from tuition nor refundable if your child does not attend aftercare at St. John's Day School.

### EXTENDED SESSION (11:45 AM – 2:45 PM)

The cost of the extended session is \$15 per day. This fee includes care and an afternoon snack. If your child stays for the extended session 3 to 5 days per week, you must change your tuition contract to 2:45 PM. The 2:45 tuition contract is discounted for those staying more than 2 days per week.

#### Monthly Payments (September 1 – June 1)

\_\_\_\_\_ We will pay for the extended session in **monthly payments of \$15 per day per month**, with the first payment due on or before the 1st day of September and on the same day of each month thereafter until paid in full.) **All monthly payments will be made through automatic bank draft, per PraxiSchool guidelines. A personal voided check must be on file in the office. All monthly payments will be withdrawn on the 1<sup>st</sup> of each consecutive month. Extended session days will be calculated on the last day of each month.**

### AFTERCARE (2:45 PM – 6:00 PM)

#### 10 Monthly Payments (August 1 – May 1)

\_\_\_\_\_ We will pay aftercare in **10 monthly payments of \$200 per month**, with the first payment due on or before the 1st day of August and on the same day of each month thereafter until paid in full.) **All monthly payments will be made through automatic bank draft, per PraxiSchool guidelines. A personal voided check must be on file in the office. All monthly payments will be withdrawn on the 1<sup>st</sup> of each month.**

#### Semester Payment (August 1 and December 1)

\_\_\_\_\_ We will pay 50% of the aftercare annual fee by August 1st and 50% by December 1st. The **2 Payments of \$1,000** will be made through automatic bank draft, per PraxiSchool guidelines. A personal voided check must be on file in the office. Semester payments will be withdrawn on the 1<sup>st</sup> day of August and 1<sup>st</sup> day of December.

#### Full Payment (August 1)

\_\_\_\_\_ We will pay the **full annual aftercare fee of \$2,000** by August 1st of the school year.

We understand that by entering into this contract with St. John's Day School, we are reserving your child's place in the extended care and/or aftercare class. We acknowledge that this contract will obligate St. John's to allocate resources for our child's education and may require the school to reject the applications of other students when class space is limited. We agree that by signing the contract, we will be obligated to pay all fees for the extended session and/or aftercare at St. John's Day School.

**A refund of, or release from, or reduction in payment of fees will only be made as follows:**

1. **Student families who move their primary residence and enrolled child from Jones County to another county during the school year will be released from the Terms of the Contract.**

If we default in the payment of all or any portion of the above sums, we agree to pay all costs of collection, including court costs and a reasonable attorney's fee incurred in the collection of the balance due.

We understand that in signing this contract for the extended session and/or aftercare, we are agreeing to uphold the school's honor system and to accept and abide by the rules and regulations of the school as stated in the Student Handbook.

**The following information must be supplied when submitting the contract:**

1. **Voided Check**

A voided check must be on file in the office. All monthly payments will be withdrawn on the 1<sup>st</sup> of the month. Second-semester payments are due on December 1<sup>st</sup>. Automatic withdrawals will be made on December 10<sup>th</sup> if payment is not received before that date.
